The Roundtable will discuss whether and to what extent Western and in particular German Political Science takes into account approaches, concepts and methods that are currently debated in the disciplinary discourse around the world – and especially in non-Western parts of the world. Are moves towards methodological pluralism and method mixes, or approaches that integrate qualitative and interpretative approaches, provided discursive space? Is the West / the global North still taken as the gold standard for measuring and judging politics? Discussants address the issue of dialogue between different conceptual and methodological approaches and how diverse geographical and cultural backgrounds can be made productive for Political Science research. Is Western and particularly German Political Science attending to the dynamics in the global disciplinary debate, or are there blind spots because research mainly focuses on established methods and approaches?
